



TERMS AND CONDITIONS

1. The Smart Streets Lab (“Lab”) is an initiative organized by WRI India Sustainable Cities and Government of Telangana (“Promoters”). By applying to this Lab, the organization agrees to and accepts all terms and conditions and the procedure set out by these terms and conditions.
2. The Lab invites eligible organizations to submit an application. The applications will be evaluated in a selection process and finalists will be invited to a bootcamp as part of the Lab cohort. Selected finalists may implement pilots in Telangana based on stakeholder engagement and interest.
3. Eligibility Criteria: To be eligible to enter the Lab, an organization must operate in an Indian city and have a registered entity.
4. Application submission:
 - a. Applications must be completed in the form and format available on the Lab website [here](#)
 - b. Applications must be completed in English
 - c. Only one application per organization will be entertained
 - d. Any applications received after the deadline for last receipt, i.e., 11:59pm IST on 1 September, 2017 will not be accepted
5. At the Promoter’s discretion, the Lab will provide the cohort with:
 - a. Bootcamp – Access to business, design, marketing and finance expertise
 - b. City Advisory – mentorship and consultations with city experts
 - c. Pilots – Training and technical workshops on pilot design and implementation
6. Applications submitted for evaluation should be authentic. If any instance of plagiarism or theft of intellectual property arises, the organization will be disqualified from the Lab.
7. The organization undertakes to indemnify and keep the Promoters harmless and indemnified against any loss, damage, claims, costs and expenses which may be incurred or suffered by them due to breach of any of the terms and conditions herein contained.
8. All selections and/or decisions made in relation to this Lab program (including without limitation, the selection of cohort) will be final and conclusive. No enquiries or complaints will be accepted or entertained.
9. The Promoters reserve the absolute right to, at their sole discretion, amend, vary and/or withdraw any of the terms and conditions of the Lab without any prior notice. In addition to these terms & conditions, other specific terms may be imposed by the Promoters from time to time to deal with any unforeseen situation. Promoters also reserve the absolute right to change the terms and conditions contained herein and, or, any other rules and regulations in respect of the Lab at any time without any notice, without assigning any reason and without any liability whatsoever. Applicants are requested to refer to such other terms and conditions, if any, which may be intimated separately as the Promoters considers fit. However, no obligation is cast on the Promoters to separately intimate each individual applicant with regard to such additional terms and conditions.
10. By submitting the application form, the applicant agrees to allow the Promoters to use the name and business description of the organization participating in the Lab on their websites and other marketing or promotional material.
11. Except for the disclosure related to pilots and unless otherwise mentioned herein, details of the applications will not be shared with any third-party without the consent of the organization. By entering into this Lab the organizations shall be deemed to have given their consent for such disclosure.





12. The Lab will coordinate with only one person during the entire process and will send all relevant communication to the designated person.
13. The Lab reserves the right to disqualify any applicant if it has grounds to believe that the applicant has breached any of the terms and conditions.
14. Nothing contained herein will be construed to constitute a contract between any participating organizations and the Promoters.
15. Incomplete information provided or failure to provide true and accurate information as stated in these terms and conditions will automatically disqualify the organization. The Promoters shall have the absolute and sole discretion to determine whether any organization should be disqualified by reason of failure to abide by these terms and conditions, bad faith, fraud or any other legitimate reason.
16. The Promoters shall not be liable in any manner whatsoever for any claims, losses, damage, costs or expenses in connection with or arising from this Lab program.
17. In the event of any inconsistency between these terms and conditions and any advertising, promotional, publicity and other materials relating to or in connection with this promotion, these terms and conditions shall prevail.
18. The Promoters shall not be liable under or in connection with these terms and conditions or for this Lab program for any indirect, special or consequential cost, expense, loss or damage even if such cost, expense, loss or damage was reasonably foreseeable or might reasonably have been contemplated by the organization and Promoters and whether arising from breach of contract, tort, negligence, breach of statutory duty or otherwise.
19. Promoters may (i) extend (ii) terminate or suspend the Lab at any time due to circumstances beyond its control (iii) substitute the components of the Lab.
20. Promoters reserve the right to reject any application without assigning any reason thereof. Any decision taken in this regard shall be final and binding and not be subject to any dispute or challenge.

Each applicant understands that each of the officials of the Promoters engaged in the organization and management of this promotion including its directors, officers, partners, employees, consultants, and agents are under no obligation to render any advice or service to any applicant in respect of this Lab.
22. Each applicant must ensure that his or her participation in the Lab is lawful in accordance with the laws of India. Neither the Promoters nor its representatives or agents shall be taken to make any representations, express or implied, as to the lawfulness of any applicant's participation in the Lab.
23. Any disputes, differences and/or any other matters in relation to and arising out of this Lab and, or pertaining to these terms and conditions shall be referred to arbitration under the Arbitration & Conciliation Act, 1996. The venue of arbitration shall be New Delhi. The Lab shall be governed by and construed in accordance with applicable laws in India and will be subject to exclusive jurisdiction of the courts at New Delhi alone.
